

The company has been awarded investment grade ratings of Aa2, AA and AA by three top credit rating agencies, Moody's, Standard & Poor and Fitch.
These ratings reflect TDIC's strong financial position and support the company's credit worthiness to investors, lenders and other market participants. TDIC has also launched a US\$ 1 billion bond sale, which represented the inaugural issuance under the US\$ 3 billion Global Medium Term Note (GMTN) programme.

Established in April 2006, TDIC has built a strong reputation among international industry players for its compelling value proposition, transparency of business approach and ability to deliver. Locally, TDIC offers significant employment and vocational training opportunities for Emiratis keen to enhance their careers and professional qualifications.

A Healthy Mixture

Six months ago, we published our first Progress Delivery Update report detailing the advancement of TDIC's major developments. Since then, along with our joint venture partners, we have delivered new hotels which have added over 1,200 new hotel rooms to Abu Dhabi.

On the financial front, TDIC has made a remarkable impression with global investors when we recently launched a US\$1 billion bonds sale, representing our inaugural issuance under a US\$3 billion Global Medium Term Note Programme. The issue of these bonds attracted substantial interest and received a total order book exceeding US\$6 billion. Also, earlier this year, we were assigned AA status by three major credit ratings agencies - Moody's, Standard & Poor's and Fitch Ratings.

We have made substantial progress on a number of our developments including Qasr Al Sarab, Desert Resort by Anantara, our luxurious desert resort, which will soon be fully operational. Set amid the sand dunes of Liwa desert in the Rub Al Khali (Empty Quarter), one of the world's largest uninterrupted deserts, this magnificent resort has been inspired by the indigenous desert culture - an integral part of the UAE's unique heritage.

Saadiyat Island, which is being completed in phases up until 2020, witnessed the groundbreakings of a number of major projects including the Louvre Abu Dhabi, Park Hyatt Resort and St. Regis Hotel and Residences. Work is almost complete on the Saadiyat Beach Golf Course, which will open at the end of 2009, while Saadiyat Bridge has just opened which links the island to the mainland for the first time in history. The 250 villas of Saadiyat Beach Residences are now in the construction phase and are scheduled for handover to their respective owners in 2011.

Since the opening of our Desert Islands destination in October 2008, many developments have taken place. The five-star Desert Islands Resort & Spa by Anantara was one of only two hotels in the region to make the Conde Nast Traveller 2009 Hot List. We also announced four new luxury lodges which will be completed by 2011, as well as a conference centre to be launched in 2010 and a number of environmentally sustainable tourism initiatives.

There is no doubt that TDIC is playing an integral part in Abu Dhabi's transformation and will continue to do so for years to come. We invite you to learn more about our announced projects in this book and look forward to keeping you updated.

جزيرة السعديات SAADIYAT ISLAND



One of TDIC's flagship developments, Saadiyat is a natural island located 500 metres off the coast of Abu Dhabi. Occupying 27 square kilometres, the entire project is due for completion by 2020 and is created around an environmentally sensitive philosophy with a special low-density master plan.

A premier island destination as well as a modern, integrated residential community, Saadiyat will eventually be home to an estimated 160,000 residents with a full complement of leisure and tourism facilities, as well as civic and cultural institutions.

Progress update

Louvre Abu Dhabi

- Mock-up works for a full-sized section of the dome are underway. Stage one, which includes the structural framing, has been completed; and stage two, which includes the cladding of the dome, is almost complete.
- Enabling Works commenced in July 2009 and will be completed by the end of the year.
- The piling works pre-qualification has been completed and tenders will be issued in the fourth quarter of 2009.
- Main contractor pre-qualification has been completed and the tender has been issued and will be announced in the fourth quarter of 2009.

Zayed National Museum

- Enabling works started in end of September 2009.
- The tender for piling works has been issued and the work is expected to start on site by the end of 2009.
- Main contractor pre-qualifications have been submitted and will be announced in the fourth quarter of 2009.

Guggenheim Abu Dhabi

- Geotechnical works have commenced which include ground and site investigation.
- Enabling works have been tendered and work will begin by the end of the year.
- Main contractor pre-qualification has been advertised in international press and the results will be announced in the fourth quarter of 2009.
 Tenders will follow subsequently.

Progress update

- Construction of the 10-lane, 1.4kilometre Saadiyat Bridge linking Abu Dhabi City with Saadiyat Island is complete and open to the public.
- The 10-lane Saadiyat Link highway is complete between Saadiyat Island and Shahama, which means closer and convenient access to Abu Dhabi airport.
- The main interchange of Saadiyat Link comprises seven bridges, one tunnel and is 90 percent complete.
 A 180 metre wide land bridge has been completed, with consideration to both residents and the natural landscape by constructing it in a trough contour making it less visible and quieter.
- The construction of a 400Kv grid station and underground cable connection to Abu Dhabi has been completed. One of the four 132Kv sub stations will be ready by the end of 2009 with the remaining three to be completed by the end of 2010. The underground cables are being installed in sequence with the sub-stations.
- A twin 1200mm water channel crossing, 10.7-kilometres storm water drainage and the 22.3-kilometre sewerage system are complete.
- TDIC has designed and installed the UAE's first purpose-built environmentally sustainable Waste Management Facility which is now operational on Saadiyat.
- Saadiyat Beach Golf Club will be ready to welcome the public by December 2009. This 72-par signature golf course, designed by golfing legend Gary Player, lies in the heart of the Saadiyat Beach District and will include an academy and an iconic clubhouse.
- Up to 27,000 plants and trees will supply the island's development from a specially developed 25hectare nursery.

- Over 500,000 seedlings grown at the Saadiyat mangrove nursery with over 155,000 planted on site. TDIC has a mangrove monitoring and management programme which provides information on mangrove health and site conditions (salinity, water quality and flow). This enables protection and enhancement of existing mangrove habitats and ensures best survival rate for seedlings.
- Construction of the luxurious villas, which are the cornerstone of the first phase of the exclusive Saadiyat Beach Residence community, is well underway. Al Jaber has been appointed for the construction and Hilalco have been appointed to undertake the infrastructure such as road works and utilities. The range of three- to eight-bedroom villas are on schedule for handover to residents in the second quarter of 2011.
- The Saadiyat Island Construction Village is being built to house up to 40,000 workers employed during the construction phase of Saadiyat. It covers 40 hectares and facilities include shops, Internet booths, recreational parks, laundry facilities and dining areas. Three-thousand people will move into the Construction Village by the end of 2009. Abu Dhabi National Hotels have been hired as the operator of the village.
- Manarat Al Saadiyat is a new experience centre being constructed and is due to be completed by November 2009. The 15,400-square metre project will include a visitor centre, sales centre, restaurant and a 250-capacity theatre. It will also host dedicated space for touring international cultural and art exhibitions. This space will be designed under international specifications to cater and house work of arts. The state-of-theart exhibition, which will be on permanent display, will provide visitors with an interactive narrative on the history and cultural vision behind Saadiyat Island.

- Principal contract agreement for appointment of Al Habtoor Engineering/Murray & Roberts joint venture was signed in July 2009.
- The contractor started site activities on August 2009.
- Works to be undertaken in 2009 primarily consist of foundations and sub-structure works with concrete structures expected to top out in July 2010.
- Construction duration is 24 months, resulting in projected soft opening taking place in the fourth quarter of 2011.
- A number of mock-up rooms are under development and are scheduled to be completed within the fourth quarter of 2009.

- The hotel is accessible both by road and air; and helipads have already been built to accommodate guests.
 A new eight-kilometre road leading through the huge sand dunes provide visitors with an awe-inspiring welcome experience.
- Construction of the property, which began in 2006, is now completed and also the hotel is due for completion and will hold its soft launch in October 2009
- Guests can visit the Desert Experience Centre, which will offer traditional desert activities including falconry, camel riding, archery, stargazing navigation and exploration of the spectacular Empty Quarter Desert. The Desert Experience Centre can arrange trips exclusively for children through the Qasr Al Sarab Kids' Club.
- Outdoor leisure pursuits include sandsurfing which make the most of Qasr Al Sarab's unique location.
- Indoor activities include a fitness centre, a yoga and aerobic studio, weights and cardio room, as well as a large swimming pool.
- Additional activities include cooking courses, storytelling and henna painting.
- Visitors can also enjoy Bedouin and local cuisine restaurants and retail outlets.

Wildlife facts

- The hotel is adjoined to a 9,000square kilometre protected wildlife reserve, the largest in the United Arab Emirates.
- Managed by Abu Dhabi Environment Agency the reserve is home to several thousand free-roaming indigenous Arabian animals, including the Arabian Oryx, mountain gazelle and sand gazelle.
- Many of the animals that have been released into the reserve were reared at a breeding and conservation reserve designed on Sir Bani Yas Island, which is part of TDIC's Desert Island project.

This unique destination lies eight kilometres off the coast of Abu Dhabi's Al Gharbia (Western Province) and the Marsa Jabel Dhanna. Desert Islands consists of a group of natural islands, including the former royal nature reserve of Sir Bani Yas Island and the historical Dalma Island.

At the core of the unique destination is Sir Bani Yas, an 87-square kilometre natural island, which has quickly established itself as leading destination for world-class environmental and conservation tourism. Home to the Arabian Wildlife Park, the island showcases nature through leisure activities including: game drives, mountain biking, kayaking, hiking, snorkelling, archery and game walks.

Progress update

- Since the 5-star, 64-room Desert Islands Resort & Spa by Anantara was opened in October 2008, the resort has attracted more than 17,000 visitors. It has won numerous awards, including making the Conde Nast Traveller Hot List as one of the top two hotels in the region,
- The Desert Islands Education
 Centre (DIEC) on Dalma Island
 opened in May 2008, is dedicated
 to up-skilling the local population
 to take part in the growing
 tourism industry on the islands.
 It already has had 487 students
 graduate from its internationally
 recognised courses and now over 40
 students were recruited in various
 governmental departments after
 taking courses with DIEC.
- A new airport terminal and a seaplane and boat terminal on Sir Bani Yas Island, as well as a boat departure terminal on the mainland have been completed, and are now in operation.
- In January 2009, a new flight service between Abu Dhabi International Airport and Sir Bani Yas Island commenced. Initially, the service was limited to two eight-seater Cessna Caravans; but in March 2009, the service was enhanced with the introduction of 50-seater weekend flight in a Dash 8. In August, both Cessna's were converted to seaplanes, becoming Abu Dhabi's only scheduled seaplane service.
- Significant wildlife and conservation programmes have been implemented, including the 're-wilding' of cheetahs and hyenas. This programme teaches the animals to hunt for themselves.
- In partnership with the Abu Dhabi Environment Agency, more than 10,000 animals were bred on the island and have been relocated back into the wild on the Abu Dhabi mainland as part of world-leading conservation programmes.

In the pipeline

- Construction of the four 5-star lodges on Sir Bani Yas Island will begin in 2009 and completion will be in phase's through 2010/2011.
- The development of a 250-seat conference centre, diving centre and an equestrian centre are scheduled to be completed in 2010.
- Development of a youth education and outdoor camp as a non-profit adventure-education programme, emphasising personal growth through experience and challenge in the wilderness, is scheduled to be completed in 2011.
- A 4,100-hectare area dedicated to local free-roaming wildlife is under development. This includes the introduction of natural predators such as cheetahs and hyenas.
- Phase Two of the Desert Island's master plan is currently being finalised by TDIC.



Al Bateen Wharf Hotel & Apartments

The development of the five-star Al Bateen Wharf Hotel & Apartments is a partnership between TDIC and the UAE's Belbadi Enterprises. 
Clubhouse




